#### 11. The Gulf of Mexico Alliance

The Gulf of Mexico Alliance is a partnership between the states of Alabama, Florida, Louisiana, Mississippi and Texas, intent on significantly increasing regional collaboration to enhance the ecological and economic health of the Gulf of Mexico. The Alliance has identified five issues that are regionally significant and can be effectively addressed through increased collaboration at the local, state and federal levels. These priorities represent an initial focus for action through the Alliance:

- Water quality for healthy beaches and shellfish beds;
- Wetland and coastal conservation and restoration;
- · Environmental education;
- Identification and characterization of Gulf habitats; and
- Reductions in nutrient inputs to coastal ecosystems.
