The following voting process will be used to select 6-8 projects for recommendation to the Task Force:

1. The Technical Committee will decide on the number of projects that each agency will vote of (6 was proposed, however, the final decision lies with the Technical Committee).

- 2. Each agency will be provided one ballot for voting.
- 3. Each agency will vote for their top projects, hand-written on the above ballot form.
- 4. A weighted score will be assigned (8, 7...etc.) or (6, 5...etc.), to be used ONLY in the event of a tie. 8 is the top weighted score if voting for 8, 6 if voting for 6.
- 5. Initial rank will be determined based upon the number of votes received for a project (unweighted).
- 6. In the event of a tie at the cutoff of 6-8 projects, the weighted score will be used as a tie-breaker (if the Technical Committee decides to break the tie).
- 7. The tied projects will be ranked based upon a sum of the weighted score.
